### Message from the Director

#### Dear Friends.

Next year, 2012 marks the 15th anniversary of the establishment of the Hong Kong Special Administrative Region. With the effort of the people of Hong Kong and the support of the Government of the People's Republic of China, Hong Kong has excelled in many areas and sustains its position as Asia's world city. We are proud to see the achievements made over the years. However, that does not mean we will be complacent and satisfied with where we are. As the world economy is predicted to be volatile in the year ahead, and with Hong Kong an open market, we have to be cautious over international developments and have to adapt ourselves with the right measures in a timely manner. While the world's attention is shifting from the West to the East and China is the center of attention, Hong Kong has to take advantage of this proximity, not just geographically but also our knowledge to it, to facilitate better understanding and collaboration within and for this region and to foster a better development globally.

### Something New

In the past twelve months, the Better Hong Kong Foundation has expanded its activities by arranging a series of meetings with Chinese ambassadors, who are posted overseas, during their visits to Hong Kong. The aim of the meetings is to address the increasing interest in the role of China in different areas. We had the honor of hosting discussion luncheons and dinners for Vice Minister Fu Ying, Ministry of Foreign Affairs of the PRC; Ambassador Liu Xiaoming, Ambassador Extraordinary and Plenipotentiary of the PRC to the United Kingdom of Great Britain and Northern Ireland; Ambassador Zhang Junsai, Ambassador Extraordinary and Plenipotentiary of the PRC to Canada; and Ambassador Liu Jianchao, Ambassador of the PRC to the Philippines.

In addition to the annual delegation to the United States, we organized our first delegation to Israel together with the Federation of Hong Kong Industries. The aim was to promote business opportunities in Hong Kong, foster closer links with the Israeli business community and to understand their investment environment, especially their hi-tech industry.

To encourage dialogue and first-hand experience through mutual visits, the Foundation organized and sponsored a high-level delegation of members from the U.S. Congress in September while discussion luncheons for two groups of congressional staffers were hosted in April and August. We invited and sponsored three Hong Kong journalism school professors to speak and participate in a conference in Beirut, to study and to better understand the impact of social media on society.

### Facilitating Mutual Understanding

The Foundation endeavors to facilitate mutual understanding between the East and the West. This year, our annual delegation to the U.S. was led by the Chairman of the Foundation's Executive Committee and Chairman of Hang Lung Properties Ltd Mr. Ronnie Chan, and was successfully held in May. This provided an excellent opportunity to renew our relationship with and to engage the interlocutors in the Beltway and New York.

The media is always an important and efficient channel for people of a country to know and understand other nations. The annual American journalist delegation, organized and sponsored by the Foundation visited Ningbo, Beijing and Hong Kong in September. This year, the delegation concluded with a conference co-organised with and held at the School of Journalism and Communication of the Chinese University of Hong Kong. Journalists were able to exchange views with local academia, media professionals and university students.

### Enhancing Discussion and Exchange

The Foundation encourages constructive discussion and exchange which is critical in building a better society. Jointly organized with the Chinese Academy of Social Sciences and the Chinese University of Hong Kong, the luncheon and press conference for the "China Urban Competitiveness Report" in Hong Kong was organized in May. Experts were invited to discuss and deliberate on the positioning of Hong Kong. The Foundation also sponsored a conference on urban planning and development in Hong Kong and China organized by the University of Hong Kong in January. In collaboration with the Shanghai Academy of Social Sciences and Shanghai Chinese People's Political Consultative Conference, a forum entitled "The 12<sup>th</sup> Five-Year Plan and Development of Hong Kong and Shanghai in 2015", the 5<sup>th</sup> of its kind, was successfully held in November. Thoughts and ideas are gathered, inspired and formulated for the betterment of Hong Kong and Shanghai.

### Journalism Exchange Programs

### The 2011 China - U.S. Journalists Exchange in September

In an effort to enhance the understanding of American media about China and Hong Kong, since 1996 the Foundation has invited 6 to 8 American journalists each year to visit China and Hong Kong. The Foundation sponsored and organized their trip. With the support of the Ministry of Foreign Affairs of the PRC, the program enables the journalists to meet with senior central government officials in Beijing and local municipal officials in one of the second or third tier cities in China. The Foundation also organizes meetings with key industry and business players, academic and research institutions and media people to broaden the participants' network other than providing them an overview of the cities they visited. This year, the Foundation, in association with the All-China Journalists Association (ACJA) and the East-West Center organized the second China-U.S. Journalists Exchange program, as an expansion of the original Hong Kong Journalism Fellows program by adding the visit of the China journalists to the U.S.

A delegation of 7 senior U.S. journalists visited Ningbo, Beijing and Hong Kong from 17 - 29 September 2011 while 7 Chinese journalists visited San Francisco. New York and Washington D.C. in the U.S. during the same period. On 23 September 2011, all Chinese and American journalists met in the ACIA to report on their experiences and to exchange opinions on how media coverage of each country can be improved. On 28 September 2011, a conference was held at the Chinese University of Hong Kong where local academia and media professionals exchanged views with the U.S. journalists. By having direct dialogue with the local authorities and communities in different areas and to see the developments by themselves, the U.S. journalists gain a better understanding of the current situation and future development of Hong Kong and Mainland China.



# Town and Gown Symposium on 30 Years of Urban Planning and Development in Hong Kong and China - Past, Present and Future in January



The Foundation, in collaboration with renowned research institutes, conducts studies on the competitiveness of urban cities in China as well as benchmarking world cities in the pursuit of excellence. We also recognize the importance of Hong Kong youth development and the cultivation of a green environment and corporate social responsibility for the betterment and sustainable development of Hong Kong.

Though Hong Kong has been ranked the top in urban competitiveness among Chinese cities for seven years since 2005, its gap between those rapidly developing cities in Mainland China such as Beijing, Shanghai and Shenzhen has been narrowed. As a whole, cooperation instead of competition prevails between Hong Kong and mainland cities with a win-win situation for all cities. The report provided useful information and insight for the positioning of Hong Kong.
